



Afterlight Pictures Submission Release Form

I or we, the undersigned (“Submitter”) are the legal owner of the submitted Film presently entitled _____, and voluntarily submit said Film, and hereby request that Afterlight Pictures, LLC (“Afterlight”) evaluate said Film. The use of the pronoun “I” will include any co-submitters who have signed below.

I understand that Afterlight has no obligation to evaluate said Film or to inform me of its evaluation, if any. In the event the Film is selected for distribution by Afterlight, I understand that a separate Distribution Agreement will be executed stipulating all terms and other obligations of both parties, and that said contract will incorporate this release by reference.

I understand that Afterlight would refuse to accept or otherwise evaluate said Film in the absence of the acceptance by me of each and all of the provisions of this release. I represent and warrant that I am the sole owner of all rights, title and interest in and to said Film; that I have the exclusive unconditional right and authority to submit said Film to Afterlight upon the terms and conditions set forth herein; and that no third party is entitled to any payment or other consideration as a condition of the use of said Film as set forth herein.

I will indemnify and hold Afterlight harmless from any and all claims, expenses, losses, or liabilities that may be asserted against or incurred by Afterlight at any time in connection with the use of said Film, including without limitation those arising from any breach or alleged breach of the warranties and promises given by me herein, including reasonable attorneys' fees and other costs incurred defending against the same.

I have obtained all clearances necessary for sale, copying and distribution of the Picture by Afterlight such that Afterlight shall not be obligated to make payment to any other individual or company, and I have full and unrestricted authority to enter into an agreement with Afterlight for these services. I guarantee, warrant and represent that sales, copying and distribution of the Film by Afterlight Pictures, LLC as described above shall not infringe any other person's or business entity's rights, or be a violation of the law or laws of any city, state, county, or country.

I retain all rights to submit this or similar material to persons or entities other than Afterlight. I knowingly acknowledge that no fiduciary or confidential relationship now exists between me and Afterlight and I further acknowledge that no such relationships are established between me and Afterlight by reason of my submission to Afterlight of said Film.

I understand that the submission of the Film to Afterlight may expose the Film to others and hereby specifically release Afterlight from any and all liability, direct or indirect, resulting from the improper use by any other persons or entities of any similar ideas, formats, stories, suggestions and the like relating to said Film. I have retained at least one copy of said Film, and release Afterlight from any and all liability for loss or other damage to copies of said Film submitted to you hereunder. I also acknowledge that Afterlight is not responsible for submissions that are lost, damaged, forged, stolen, misdirected, misplaced. This release extends to Afterlight Pictures, LLC, its agents, associates, employees, officers, members, directors shareholders, and volunteers.

I hereby acknowledge and agree that there are no prior or contemporaneous agreements, oral or otherwise, in effect between Afterlight and me pertaining to said Film including, but not limited to, agreements pertaining to the submissions by me of any ideas, formats, plots, characters, or the like. I further agree that no other obligations exist or shall exist or be deemed to exist unless and until a formal written agreement has been prepared and entered into by Afterlight and me.
